Duration, renewal and termination

- The agreement is concluded for a minimum contract period of 12 months. Unless the customer/subscriber gives written notice before the expiry of the initial period, the agreement will be automatically extended for an indefinite period.
- The customer/subscriber with a maximum of 9 employees can terminate the agreement at a self-chosen moment, even if this is immediate. The customer/subscriber with more than 9 employees can be held to a notice period of maximum 1 month upon termination of the agreement after its tacit renewal for an indefinite period.
- If the customer/subscriber decides to terminate the agreement early during the minimum term, compensation for early termination of the agreement can be claimed by law. For a customer/subscriber with more than 9 employees, this compensation is equated to the sum of the remaining monthly amounts up to and including the end of the minimum term. For a customer/subscriber with a maximum of 9 employees, the compensation is limited to the totality of the monthly subscription fee that is still due until the end of the first 6 months after the entry into force of the agreement.
- The burden of proof of the number of employees lies with the customer/subscriber.
