### Speeds of the internet service and remedies<sup>3</sup>

The advertised maximum speed of up to 12 Mbps for download and up to 0,740 Mbps for upload is the value of the speed that edpnet mentions in all its commercial communications around the ADSL XL subscription. It is a theoretical maximum speed that depends on the distance between the connection point and the DSL equipment, the load on the network, the quality of the internal cabling and the computer used, the quality of the wireless network (wifi)... The presumably achievable speed at a location can be tested on this edpnet page. After activation of the subscription, the current speed profile can be viewed via my.edpnet.be, via the widget "my internet", by clicking on "manage my subscription".
